# LUXAGRO COOKIE POLICY

LuxAgro ("we", "us", "our") operates the website https://www.luxagro.online/ (the "Site"). This Cookie Policy explains what cookies are, how we use them, the types of cookies we use, and how you can manage or refuse them. - · Advertising and Targeting Cookies: We use third-party cookies, including those placed by advertising networks, to deliver relevant advertisements to you and measure the effectiveness of our advertising campaigns.

· *Third-Party Cookies:* Some of our cookies may be placed by third-party services that appear on our pages. These cookies are governed by the privacy policies of those third parties and may be used for marketing or other purposes. We do not control third-party cookies.

# 4. LEGAL BASIS FOR PROCESSING

In compliance with the General Data Protection Regulation (GDPR), we process cookies based on the following legal grounds:

- · Consent: We will request your consent before setting cookies on your device, except for strictly necessary cookies that enable the basic functionality of our website. By continuing to use the Site after seeing a cookie banner, you consent to our use of cookies.
- · Legitimate Interests: In some cases, we use cookies to improve our website's functionality and performance, which aligns with our legitimate interest to provide a better service to our users.

# 5. HOW TO MANAGE OR DISABLE COOKIES

You can control or delete cookies using the following methods:

- · Browser Settings: Most web browsers automatically accept cookies, but you can modify your settings to reject or delete cookies.
